DID YOU KNOW? MEDICARE DOESN'T COVER DENTAL, VISION, OR HEARING

Medicare doesn't cover most dental care or procedures—like cleanings, fillings, tooth extractions, dentures, dental plates, etc. Routine eye exams, eyeglasses, and/or contact lenses are also not covered.

Medicare also doesn't cover hearing aids, hearing exams, or exams for fitting hearing aids. You pay 100% for hearing exams and hearing aids.

There are specific insurance plans that help fill in this coverage gap called Dental, Vision, and Hearing (DVH) plans.

WHITE CHOCOLATE BARK

INGREDIENTS

- 1 tablespoon butter, melted
- 2 (10-12 oz.)
 packages of white
 baking chips
- 1-1^{1/2} cups walnut halves
- 1 cup dried cranberries
- 1/4 teaspoon ground nutmeg



DIRECTIONS

PART B (MEDICAL)

Part B Deductible - YOU PAY... \$240 per calendar year

PART B PREMIUM (including high income Part B & Part D) [paid to Medicare]

Those enrolled in Part B will pay at least the standard \$174.70/mo premium (based on income). Higher income earners will pay a Part B IRMAA (Income Related Monthly Adjustment) in addition to the \$174.70/mo standard premium.

Those with higher income, who are enrolled in Part D Prescription Drug coverage, also pay a Part D IRMAA in addition to the monthly insurance premium for a Part D prescription drug plan or Medicare Advantage plan that includes Part D coverage.
